**NOTICE OF PUBLIC HEARING**

This Notice of Public Hearing is given, pursuant to O.C.G.A. §33-13-3(d), concerning the proposed ACQUISITION OF CONTROL OF A DOMESTIC INSURER, Humana Employer’s Health Plan of Georgia, Inc. (the “Domestic Insurer”), by Aetna Inc. (the “Applicant”). The Form A Statement of Applicant concerning the proposed acquisition was initially filed with the Office of Commissioner of Insurance on July 3, 2015 (the “Initial Filing”). The Initial Filing did not include all of the documentation necessary to conduct a thorough review of this filing. Additionally, due to the size and scope of this proposed acquisition, the Office of the Commissioner of Insurance (“Office”) hired an economist to examine particular aspects of the proposed acquisition. Although all aspects of the review of this filing are not yet complete, the Office is ready to move forward with the issuance of this Notice of Public Hearing.

Accordingly, the public hearing on the proposed acquisition of control will be held before the Commissioner of Insurance (“Commissioner”), on **Tuesday, July 26, 2016**, and, if necessary, on **Thursday, July 28, 2016**, and from time to time thereafter until the matter is

concluded. Each day of the public hearing shall commence at 9:00 a.m. and shall continue that day until adjourned by the Commissioner. The public hearing will be held at the Georgia Department of Insurance in Suite 916, West Tower, Floyd Building, 2 Martin Luther King, Jr. Drive, Atlanta, Georgia, 30334.

Members of the public who would like to offer oral comments at the public hearing regarding the proposed transaction will be afforded the opportunity to do so. Oral comments may be limited to five (5) minutes per person in order to allow all persons an opportunity to be heard. Persons who wish to submit written comments to the Office may submit those comments to [mergercomments@oci.ga.gov](mailto:mergercomments@oci.ga.gov) or to the Office of the Commissioner of Insurance, Attention: Administrative Procedure Division, Suite 1016, West Tower, Floyd Building, 2 Martin Luther King, Jr. Drive, Atlanta, Georgia 30334. All written comments must be received by **4:30 p.m. on Thursday, July 21, 2016.**


Any person who wishes to intervene to become a party to the public hearing must file a Motion to Intervene, which must be received by the Administrative Procedure Division of the Office no later than **4:30 p.m. on Wednesday, July 6, 2016.** Any current party to the public hearing that wishes to oppose such a motion must file a Motion in Opposition to the Motion to Intervene, which must be received by the Administrative Procedure Division of the Office no later than **4:30 p.m. on Tuesday, July 12, 2016.** The Commissioner will rule on any Motions to Intervene by **4:30 p.m. on Tuesday, July 19, 2016.** All discovery proceedings shall be concluded not later than three days prior to the commencement of the public hearing.

Pursuant to O.C.G.A. §33-13-3(d), not less than seven days' notice of the public hearing shall be given by the Applicant to the Domestic Insurer, to the shareholders of the Domestic Insurer and to any other persons as may be designated by the Commissioner. Moreover, the

Applicant shall publish this Notice of Public Hearing in its entirety in the The Fulton County Daily Report, the official legal organ for notification of legal matters pending in Fulton County, Georgia, no later than **June 28, 2016**.

After the conclusion of the public hearing and the closing of the record in this matter, the Commissioner will make a determination to approve or disapprove the proposed change of control in accordance with his findings as authorized by law.
